Report of the

Superintendent of Schools

Members of the School Committee, Selectmen, and Citizens: My dear Friends.;

It gives me a great deal of pleasure to submit by tenth annual report of schools. The depression has been more severe with us in Mains than previously. It has been particularly difficult for towns like North Kennebunkport where there are few industries. However, there are many hopeful angles to encourage us. The capital outlay at Burnham School has been attended to and the extra school maintained on the estimated cost with a slight balance. The state subsidy is slightly above what it was last year. These are the bright spots in my report.

However, may I point out that your school problems have mounted each year for the past few years due to the coming of new properties into your town. These new homes point inevitably to a steadily increasing population. Indeed, the school population has doubled within a few years.

The enrollment in September for the schools of North Kenne. bunkport reveals this tendency of increased numbers to overflow your ability to house them. I shall present the enrollment data as it appeared early in September. There has been fluctuation in these figures in only one school. The others are nearly the same as when the study was made. North Chapel enrolled 15 pupils which was the smallest school in town on opening. The Irving school enrolled 16. This number has been reduced. The Iron Bridge school enrolled .18 pupils. This was a capacity enrollment for the space at this school., The Durell (school has a capacity enrollment of 28. The first three grades at Burnham have an enrollment of 28. The Burnham enrollment for grades four to nine is 28. You note at once that there are as many pupils in the first three grades as there are m the remaining six, grades. This ratio indicates capacity enrollment in the near future. There were enrolled in your schools in September 133 pupils. In 1926, when I took up supervision in your town there were only 140 pupils in your census between 5 and 21 years of age. Only 54 pupils were registered in your schools that year. This is a growth of 244 per cent. There are more pupils of either sex in your schools today than there were in both sexes in 1926. This may serve to indicate the unusual growth in enrollment and the corresponding problems you are

asked to consider. When the enrollment data was compiled there were 63 girls in your schools and 70 boys. You will be interested in and find much detailed information in the ago distribution chart presented herewith:

Your attention at this point may properly be called to a unique development in your schools, that has this year taken place at the Burnham school. A plan for departmentalizing the teaching of the grades at Burnham school has been effected. The Committee approved the plan. The teachers were consulted and welcomed the plan and helped in the set-up. They were so heartily in favor of the project and receptive to the experiment that from th 3 beginning there has not been a single drawback of any importance. Accordingly the teachers have chosen the subjects in which each had a feeling of proficiency and personal pleasure. -The classes pass for recitation from room to room and this very mobility is both salutary and beneficial. We are able to expand somewhat the curriculum and to diversify the teaching. The teachers have reported progress beyond our first hopes and bid fair to continue. This experiment is without expanse of neither time or money when compared with the older method. This is the only rural school in my Union that has this advance service.

At the present time some indications seem to point to the fact. that Irving School enrollment may fall below the 1500 aggregate attendance if there should b3 any more pupils transfer from the school. Within a few weeks, seven pupils have been transferred from this school to schools in the nearby towns. If this school should fall below the aggregate attendance of 1500, you will have to have a vote of the town to keep it open. This is the thing to do, I think, in the event of the requisite number of attendance days being below that required by law.

Tuition costs have developed rapidly on the elementary school level due to the large families coming into your town who live in territory adjacent to the Kennebunk schools. There, were 14 pupils reported attending Alewive school belonging to North Kennebunkport. The Town House Primary reported three pupils. The Town House Grammar School has four pupils.

There are four High School pupils of North Kennebunkport attending Biddeford High School, six are attending Kennebunk High School, one is attending Kennebunkport High School ar two are attending Thornton Academy. This makes a considerable tuition for those going forward to higher types of learning, but is little changed from the conditions reported last year.

All of these tuition costs are in the nature of fixed charges and as such, we have no control over them. The reports from these pupils are most favorable as far as the intellectual progress is concerned.

You voted in special meeting to open the school at Burnham and appropriated money, after your tax commitment had been made, for this purpose. The school property at Burnham was put into shape and the necessary changes made for the holding of school in the annex. It proved to be the only way that the pupils coming to this school could be accommodated.

Warrant For Town Meeting, March 4, 1935 STATE OF MAINE

County of York, ss.

To Florence R. Hayes, Constable of the Town of North

Kennebunkport, in said county. Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said town of North Kennebunkport, qualified by law to vote in town affairs, to assemble at the Town House, in said town, on the 4th day of March, 1935, at ten o'clock in the forenoon to act on the following articles, to wit:

Article 1. To choose a Moderator to preside at said meeting.

Article 2. To see if the Town will vote to dispense with the use of the check list at this meeting.

Article. 3. To choose all necessary Town Officers for the ensuing year.

Article 4. To see what sum of money the Town will vote to raise for the support of the Common Schools, (Budget Committee recommends \$3,000.)

Article 5. To see if the Town will vote to raise \$1075 and one year's interest at six per cent, to pay the note for financing the new half of the Burnham School (Committee recommends vote "yes").

Article 6. To see what sum of money the Town will vote to raise for High School Tuition.

Article 7. To see what sum the Town will vote to raise tor repairs and insurance on School Building's. (Committee recommends \$50.)

Article 8. To see what sum the Town will vote to raise for Free Text Books. (Committee recommends \$75.) Article 9. To see what sum the Town will vote to raise for School Supplies. (Committee recommends \$75.7

Article 10. To see what sum the Town will vote to raise for salary of Superintendent of Schools. (Committee recommends \$:(57(5d)

Article 11. To see if the Town will vote to, continue the Irving School if attendance should fall below that required by the State. (Committee recommends "yes.")

Article 12. To see what sum the Town will vote to raise for repair of Roads and Bridges, and see what sum shall be paid to the Road Commissioners per day for their services, and fix the price per hour for labor on highways.

(Committee recommends raise \$1,200 road commissioners to receive \$3.00 per day, and labor \$2.25 for ninehour day.)

Article 13. To see if the Town will vote "Yes" or "No" on the question of raising and appropriating money necessary to entitle the Town to State Aid as provided in Sec. 20, Chap. 28, R. S. 1930. (Committee recommends vote "no".)

Article 14. To see what sum the Town will vote to raise and appropriate for the improvement of the section of State Aid Road as outlined in report of State Highway Commission (in addition to the amounts regularly raised for the care of ways, highways and bridges) under provisions of Sec. 19, Chap. 28 R. S. 1930, or under provisions of Sec. 3, Chap. 175, P. L. 1933. (Committee recommends vote "no")

Article 15. To see if the Town will vote to raise a sum of money to cut and destroy all bushes on State Highway, State Aid and Third Class Roads, to comply with Chap. 145, P. L. 1927, and if so, how much. (Committee recommends vote "no.") Article 16. To see if the Town will vote to raise the sum of four hundred seventy-four dollars to repair and maintain Third Class Roads, to comply with Sec. 43 to 47, Chap. 28, R. S. 1930, as amended by Chap.175. P. L. 1933 (Committee recommends vote "no.")

Article 17. To see what sum the Town will vote to raise to be used with a special resolve sum received from the State for improvement of the Proctor road (Com. recommends that it be indefinitely postponed)

Article 18. On petition of B. F. Lombard and twentyone others, to see if the Town will vote to raise the sum of \$200 to gravel the Burnham road from the residence of Philip Pearson to the corner at Burnham schoolhouse. (Corn. recommends that it be indefinitely postponed.)

Article 19. To see if the Town will vote to raise-\$760.35 to reimburse the State for the cost of 'Day's. Mills bridge.

(Committee recommends vote "yes "

Article 20. To see what sum the Town will vote to raise for the removal of snow. (Committee recommend \$1,000)

Article 21. To see what sum the Town will vote to raise for support of poor.

(Committee recommends \$2000.)

Article 22. To see what sum the T0wn will vote to raise for the contingent fund. (Committee recommends \$1500.)

Article 23. To see if the Town will vote to raise a sum of money to be used in payment of services of outof-town fire companies,

(Committee recommends vote "yes.")

Article 24. To see if the Town will vote to raise a sum of money to provide for the services of a public health nurse, or take action thereon. This action is made legal by the Maine Legislature of 1925, Sec. 58, Chap. 140, of 1925 P. L. (Committee recommends vote "yes.") Article 25. To see if the Town will vote to authorize the issue of bonds of the Town, in a sum not exceeding \$10,000, for refunding or paying outstanding notes and validate such notes.

(Committee recommends bonds to draw inter-

Article 26. To see if the Town will vote to authorize the Treasurer to execute quit claim deeds to Adra L. Day, to cover Town's claim against John Fletcher property; also quit claim deed to Frank W. Wormwood to cover Town's claim against F. H. Moulen property. (Committee recommends vote "yes.")

Article 27. To see what sum the Town will vote to pay for the collection of taxes, (Committee recommends one and one-half per cent.)

Article 28. To see if the Town will vote to instruct the Town Clerk, Treasurer, and Collector of Taxes, each to appoint a deputy to have authority to act in the absence of said officer during- all reasonable business hours. (Committee recommends vote "yes")

Article 29. To see if the Town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said Town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the Town Treasurer be and is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate ten thousand dollars, and to execute and deliver the note or notes of the Town therefor, signed by the Town Treasurer and countersigned by the Municipal Officers of the Town,

Article 30. To see if the Town will vote that all articles to be inserted in Town Warrant hereafter, be submitted to Chairman of Board of Selectmen not later than two weeks previous to date of Town Meeting. Article 31. To see if the Town will vote that hereafter all unpaid taxes shall be published in Town Report. (Committee recommends vote "yes.")

Article 32. To see if the Town will vote that hereafter all individual bills for labor or material shall be paid by town orders,

(Committee recommends vote "yes.")

Article 33. To see if the Town will vote to instruct. the Tax Collector to take advantage of the Tax Lien Law instead of the procedure now in force as regards unpaid taxes.

(Committee recommends vote "yes.")

Article 34. To see if the Town will vote to instruct the Selectmen to appoint a Building Inspector, and to approve Town Ordinances to govern the same.

Article 35. To see if the Town will vote to instruct. the Selectmen to appoint a Fire Warden.

Article 36. To act on any other business which n. legally come before said meeting.

The Selectmen hereby give notice that they will be in session at Town House at nine o'clock in the forenoon of the day of said meeting, for the purpose of revising and correcting list of voters.
