Report of the Superintendent

of Schools

To the Honorable School Committee, Board of Selectmen, and Citizens of North Kennebunkport:

Ladies and Gentlemen:

It is with unusual pleasure that I submit this. my fourteenth annual report of schools.

The statistical data of your school census reveals an ever increasing school problem. Indeed your census is at an all-time high with 28 more pupils between the ages of five and twenty-one than has been registered in 20 years. For instance, there are more than twice the number of census pupils than were reported in the year 1931. Over the fourteen years I have been in charge of your schools the enrollment of scholars in your schools has risen correspondingly with the growth of the census. In 1926 there were only 54 pupils attending school. This year there are 146 pupils attending your schools.

Your schools with the exception of the North Chapel school are crowded to capacity with little chance of expansion. Your elementary system may need a new school room and another teacher this coming fall. This will be serious and special consideration should be given as to how the town proposes to handle this growing school problem. At the same time your elementary

schools began to overflow their accommodations, the secondary tuition began also to rapidly demand an enlarged budget.

In 1926 only three school buildings were in service. now six are either crowded or overflowing. in 1926 there were 10 pupils in the High School, where as in 1939 we are reporting 25 pupils in High School. This growth and added expense comes at a time when your tax structure is less able to bear this extra burden than it was when your town was set off by itself. The growth in school population is far, (and away) out of proportion with the tax income this increased population represents.

In December 1938 data showing the per capita cost of school and municipal expense per dollar of valuation were given out by the State. This year the average of school rates is .01270 while the average of municipal rates is .05732 taken on a State wide basis. North Kennebunkport has a school rate of .01642 and a municipal rate of .064. In other words your school rate is .00372 above the average taken on a State wide basis. At the same time your municipal rate exceeds the State average .0068 cents per dollar of valuation.

At the last legislature an equalization fund was set up which has helped us in purchasing such books as could not have been provided otherwise. The teachers were given overloaded grades and a slight increase was given from this fund to compensate for the extra work. Moreover, certain supplies were purchased which could not

have been had except for this equalization fund provided by the State.

In allocating the equalization fund the State Commissioner, Bertram E. Packard, sent the following definite instructions: "You should further," said he, "bear in mind that the equalization fund cannot be considered as tax reduction measure." The reason for this is that the equalization fund is insufficient to meet the full need as to the guaranteeing of a minimum programme, and should be regarded by school officials, and thoroughly explained to citizens, as a fund to improve educational opportunities in the sharing towns beyond those afforded by current appropriations. You must, of course, bear in mind that in order for a town to share, its appropriation must be such as to make a tax rate equal to or in excess the average of tax rates for the school maintenance. The amounts available for distribution will be apportioned to the one hundred eighty-three towns on a percentage basis of need. the percentage starting at 50% for towns barely meeting the requirements for eligibility increasing to 90% for towns having the highest tax rate for the support of schools, as follows:

50% to Towns having a school rate between .01270 and .01350

60% to Towns having a school rate between .01350 "and .01550

70% to Towns having a school rate between .01550 and .01750

80% to Towns having a school rate between .01750 and .02050

90% to Towns having a school rate between .02050 and above.

This past year the fund amounted to \$587. If you follow through with the needed budget as recommended, I shall hope, all things being equal, such as census, enrollment, etc., the equalization fund will likely be \$634 for the ensuing year.

The health conditions in your schools are generally much better than last year. There has been no general epidemic. The usual colds have prevailed but no greater than is to be found under winter conditions.

At the end of the fall term in December, Mrs. Grace Ham Smith asked for a leave of absence for the remainder of the year. This was granted, and a substitute teacher, Miss Roberta McCarthy, was sent to the North Chapel school to fill out the year. Miss McCarthy is a graduate of Kent State University in Ohio and should be well qualified for this work. I am sorry to report that the discipline at the North Chapel school has been a very disquieting problem for the Superintending School Committee and the teacher. I sincerely hope the discipline problem at North Chapel will soon be adjusted.

I feel that your town has carried through the depression and done all you can to help maintain good schools.

You certainly can meet the problems immediately ahead of you with a knowledge that in some respects you

are better off than two or three, years ago. It can be pointed out that the equalization fund has given extra books and supplies that makes possible good work that otherwise would lie impossible.

In conclusion I wish to thank the teachers for the cooperation and fine devotion they have given to their work. It has been of a high type and very progressive. The Superintending School Committee has been willing to devote much earnest thought to school affairs and have been helpful on all occasions. The citizens for the most part have been proud of the achievements of their pupils and have supported the school programme loyally. Finally, let me say that much good teaching and a high goal of attainment has been reached in your schools this past year,

Report of Public Health Nurse

To the Citizens of the Town of North Kennebunkport.

I hereby submit my annual report as Public Health
Nurse for the year 1938.

The routine health inspections were done in two visits
to each school during the year with a part of the inspection
having been done at each visit. The following is the

During the year many follow-up visits were made to
the homes of school children because of illness or because
of defects found during health inspections. Through aid

from the Kennebunkport Red Cross arrangements were made at the Trull Hospital for one boy to have a tonsillectomy operation. Another child was taken to the office of an oculist in Sanford for examination of her eyes. At the request of one teacher a call was made to one school for a special inspection for evidence of skin disease. Follow-up calls were made to the homes of those excluded from school because of the skin disease. Other visits were made to homes because of persistent cases of head lice. Several calls have been made to the home of a child ill and under medical care.

I wish at this time to assure you that the cooperation of all in your community is appreciated and I hope you will continue to call upon me for any service which I may be able to render you.

To all who have helped with the health work this year. I am grateful.

WARRANT

For Town Meeting, March 6, 1939

STATE OF MAINE

To Florence R. Hayes, Constable of the Town of North
Kennebunkport in said County. Greeting's:

In the name of the State of Maine, you are hereby
required to notify and warn the inhabitants of said town
of North Kennebunkport, qualified by law to vote in
town affairs, to assemble at the Town House, in said
town. on the 6th day of March, 1939, at ten o'clock in
the forenoon, to act on the following- articles, to wit:

Article 1. To choose a moderator to preside at said
meeting.

Article 2. To see if the town will vote to dispense
with the check list at this meeting.

Article 3. To choose all necessary town officers for
the ensuing year.

Article 4. To see what sum of money the town will
vote to raise for the support of common schools.

Article 5. To see what sum of money the town will vote to raise for high school tuition.

Article 6. To see what sum of money the town will vote to raise for repairs and insurance on school buildings.

Article 7. To see what sum of money the town will vote to raise for free textbooks.

Article 8. To see what sum of money the town will vote to raise for school supplies.

Article 9. To see what sum of money the town will vote to raise for the salary of superintendent of schools.

Article 10. To see what sum of money the town will vote to raise for the repair of roads and bridges.

Article 11. To see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour for labor on highways.

Article 12. To see if the town will vote to divide the common road appropriation between its road commissioners on a mileage basis.

Article 13. To see what sum the town will appropriate for State aid road construction (in addition to the

amounts regularly raised for the care of ways, highways and bridges) under the provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 229, Public Laws of 1937.

Article 14. To see if the town will vote to raise a sum of money to cut and destroy all bushes on State highway. State aid, and third class roads, to comply with Chapter 145, Public Laws of 1937. and it so. how much.

Article 15. To see if the town will vote to raise the sum of five hundred and one dollars to repair and maintain third class roads, to comply with Sections 43 to 47, Chapter 28, Revised Statutes of 1930, as amended by Chapter 175, Public Laws of 1933,

Article 16. To see if the town will vote to raise a sum of money to pay bond and interest coming due this year.

Article 17. To see what sum the town will raise for the removal of snow.

Article 18. To see what sum the town will raise for the support of poor.

Article 19. To see what sum the town will raise for the contingent fund.

Article 20. To see if the town will vote to raise a sum

of money to provide for the services of a public health nurse, or take action thereon. This action is made legal by the Maine Legislature of 1925, Section 58, Chapter 140, Public Laws of 1925.

Article 21. To see what sum the town will vote to pay for the collection of excise taxes.

Article. 22. To see what sum the town will vote to pay for the collection of taxes.

Article 23. To see If the town will vote that for the purpose of procuring' a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate ten thousand dollars, and to execute, and deliver the note or notes of the town therefor, signed by the town treasurer and countersigned by the municipal officers of the town.

Article 24. To see if the town will vote to raise a sum of money to pay mortgage on Frank Furbish property.

Article 25. To see if the town will vote to raise a sum of money to purchase one V-shape snow plow to be used in front of truck.

Article 26. To see if the town will vote to raise the salary of the Chairman of the Board of Selectmen to \$300.00.

Article 27. To see if the town will authorize the treasurer and collector to sell and dispose of all tax titles held by the town on such terms as they deem advisable, and to execute quit claim deeds for such property.

Article 28. To see if the town will vote to raise the sum of \$300.00 for the services of out of town fire companies.

Article 29. To hear the report of committee on by-laws.

Article 30. To see if the town will vote to instruct the selectmen to appoint a building inspector, to work under instructions as laid down in Chapter 35, Section 25-36. Revised Statutes.

Article. 31. To see if the town will vote to instruct the selectmen to appoint an electrical inspector.

Article 32. To see what sum of money the town will vote to raise and appropriate for advertising our natural resources, advantages and attractions, under the provisions of Chapter 5, Section 82, of the Revised Statutes of 1930, said sum to lie expended under the direction of the State of Maine Publicity Bureau.

Article 33. To see if the town will vote to raise the sum of \$200.00 for the control of Blister Rust for the coming year.

Article 34. To act on any further business that may come before this meeting.
