REPORT OF THE SUPERINTENDENT

OF SCHOOLS

To the Honorable School Committee, Board of Selectmen, and Citizens of North Kennebunkport:

LADIES AND GENTLEMEN:

This is my seventeenth annual report of schools and I feel that, in many ways, your schools are doing better work than at any time of which I have knowledge.

There has been a notable advance this year in the condition of the physical properties of the schools. I refer to the installation of the lighting fixtures which are greatly appreciated. These installations enable a much better type of work in the schools. This is a recognition that good eyesight is necessary now as never before.

I desire to call your attention to the increased enrollment in your schools and to point out the inevitability of finding new quarters if the growth in the enrollment further increases.

If you turn to the comparative data showing school reports from 1926 to 1941, you will see that your school population has doubled in this period. From 1940 to 1941, the census increase was 12 and also, the enrollment in your schools showed an increase of 12%. When you consider that in every year, save three, of the past sixteen years, there has been an increase in enrollment, it readily becomes plain why your schools are overcrowded. Moreover, you have 34 pupils attending secondary schools and this tuition is likewise mounting.

There are several large families now entitled to send their pupils to the public schools, who have elected for the present to send them out of town. If these pupils should be sent to the public schools now or at any time in the immediate future, there would be no place for them to go.

Burnham, Durell, Iron Bridge, and Irving Schools are already overcrowded. Your budget should contemplate a new schoolroom at the Town Hall. If this contingency should become a reality, the shortage of teachers is so acute, that qualified teachers are just not to be had. You are fortunate indeed to have teachers of such high standards and so well equipped to carry forward the school work in these times when the wages outside are depleting the teaching force in every quarter.

THE EQUALIZATION FUND

The Equalization Fund has enabled your town to face the increased load imposed on the schools, by the emergency, with an advance in the tools of learning and a stabilization of the teachers' wages, which otherwise could only have been done by excess taxation. Your schools have been extended two weeks by the utilization of this fund and your town now has a system of textbooks that is unequalled in any of the surrounding towns whatever their financial standing.

This favorable situation did not come about by itself. It came about because you have been willing to see to it that your school budget was kept up to that average of state expenditure that entitled you to share with those towns, in the state, that exceeded the average. This was in reality little more than you would have been compelled to do under the normal condition that has faced you over the past sixteen years.

TRANSPORTATION

A second transportation line was forced on your town when Biddeford voted to close the Mountain Road School, known as District 13. These pupils lived on dangerous roads at such a distance as to make transportation imperative. Mr. Fred A. Durell was hired by the Superintending School Committee to transport these pupils, who formerly attended the Mountain Road School, to the North Chapel School.

Mrs. Margaret E. Emmons transports the North Kennebunkport scholars, who formerly attended the Alewive School, to the Irving School.

There are recent state decisions of law that leave the School Committee less option in the determining of distances pupils may walk to school. There is, for instance, a law court decision, the logic of which makes the transportation advisable if the highway is narrow and much traveled. This would apply to the Alfred Road according to some State officials. This growing accumulation of precedents seems to make the transportation on the Alfred Road imperative. This route was set

up at \$15.00 per week.

The total American picture is one that gives you all a great many questions about the future. In any appraisal of our deepest concerns, our future welfare immediately leads us to see that education should be cherished, fostered, and advanced as never before.

Total war calls for a total educational backing such as we Americans have never given in any past emergency.

The trivial fault finding and heckling of the teacher from every backward or reactionary parent who happens to have some unadjusted and delinquent child has become the persistently common and usual thing.

America has come in the past to expect to slow the school work to the incompetent and the laggard. No compulsion was or could be used. It would seem that we realize that this emergency denies to us all this easy road if we are to win. Schools must accept the road to mastery. It should be understood that schools must again put stress on using the potentialities of the brilliant and the gifted in order for them to rise up and help preserve the freedoms which we have. Parents should rejoice if the teachers are anxious that the child should work with the dedication worthy of that freedom.

The day of mastery in school subjects has again dawned and we shall measure only to the great challenge in proportion to the mastery that teachers and pupils place upon the fundamentals. The mechanized, scientific, and socialized age can not bring us to preeminence except by the mastery of the tools of our age. The parent should be restless if his child does not utilize his full talents and industry in the mastery of this fact world on the elementary school level.

REPORT OF PUBLIC HEALTH NURSE

To the Citizens of the Town of North Kennebunk port:

I hereby submit my annual report as public health nurse for the year beginning January 1, 1941, and ending December 31, 1941

Numerous visits were made during the year to the various schools in town. Some were made at the special request of teachers for the purpose of checking up on evidence found of suspicious skin diseases. Home visits were made on many of these pupils to instruct the parents as to proper treatment. A home visit was made at one school where a pupil was thought to be mentally defective and the mother urged to take the child to her family physician for advice and treatment. Aid was secured through the Kennebunkport Red Cross Chapter for another child, referred by a teacher, for necessary dental corrections. It was a pleasure, in June, to accept the invitation of the teachers at the Burnham School to attend their graduating exercises and present the Seven-Point awards and pins to many of the pupils. The regular health inspection was completed in two visits to each school during the year. The following is a report of the inspections as completed for 1941:

WARRANT

For Town Meeting, March 2, 1942

STATE OF MAINE

COUNTY OF YOKK, SS.

To Florence R. Hayes, Constable of the Town of North Kennebunkport, in said County, GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of North Kennebunkport, qualified by law to vote in town affairs, to assemble at the Town House, in said town, on the 2nd day of March, 1942, at ten o'clock in the forenoon, to act on the following articles, to wit:

Article 1. To choose a moderator to preside at said meeting.

Article 2. To see if the town will vote to dispense with the check list at this meeting.

Article 3. To choose all necessary town officers for the ensuing year.

Article 4. To see what sum of money the town will vote to raise for the support of common schools.

Article 5. To see what sum of money the town will vote to raise for high school tuition.

Article 6. To see what sum of money the town will vote to raise for repairs and insurance on school buildings,

Article 7. To sec what sum of money the town will vote to raise for free textbooks;

Article 8. To see what sum of money the town will vote to raise for school supplies.

Article 9. To see what sum of money the town will vote to raise for the salary of the superintendent of schools.

Article 10. To see what sum of money the town will vote to raise for the repair of roads and bridges:

Article 11. To see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour to be paid for labor on highways.

Article 12. To see what sum of money the town will appropriate for State aid road construction (in addition to the amounts regularly raised for the care of ways and highways and bridges) under the provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 229, Public Laws of 1937.

Article 13. To see if the town will vote to raise a sum of money to cut and destroy all bushes on State highways, State aid and third class roads, to comply with Chapter 145, Public Laws of 1937, and if so, how much.

Article 14. To see if the town will vote to raise the sum of four hundred and seven dollars to repair and maintain third class roads, to comply with Sections 43 to 47, Chapter 28, Revised Statutes of 1930, as amended by Chapter 175, Public Laws of 1933.

Article 15. To see if the town will vote to raise the sum of \$1,120.00 to pay bond and interest coming due this year.

Article 16. To see what sum of money the town will vote to raise for the removal of snow.

Article 17. To see what sum of money the town will vote to raise for the support of the poor.

Article 18. To see what sum of money the town will vote to raise for the contingent fund.

Article 19. To see if the town will vote to raise a sum of money to provide for the services of a public health nurse, this action made legal by the Maine Legislature of 1925, Section 58, Chapter 140, Public Laws of 1925.

Article 20. To see what sum of money the town will vote to pay for the collection of excise taxes.

Article 21. To see what sum the town will vote to pay for the collection of taxes.

Article 22. To see if the town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and hereby is authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate ten thousand dollars, and to execute and deliver the note or notes of the town therefor, signed by the town treasurer and countersigned by the municipal officers of the town.

Article 23. To see if the town will authorize the treasurer of the town (with the approval of the board of selectmen) to sell and dispose of all tax titles held by the town on such terms as they deem advisable, and to execute quitclaim deeds for such property.

Article 24. To see what sum of money the town will vote to raise for the services of out-of-town fire companies.

Article 25. To see if the town will vote to instruct the selectmen to appoint a building inspector, to act under instructions as laid down in Chapter 35, Sections 25-26, Revised Statutes.

Article 26. To see if the town will vote to instruct the selectmen to appoint an electrical inspector.

Article 27. To see if the inhabitants of the town will ratify the action of the town treasurer, and the board of selectmen, in the granting of an easement to the New England Telephone and Telegraph Company to lay, construct, reconstruct, operate, maintain, replace and remove lines of telephone and telegraph, including the necessary underground cables and associated construction, across, over and under town property, known as the "Gravel Pit" in North Kennebunkport, Maine. Deed to New England Telephone and Telegraph Company, dated August 18, 1941, is recorded in York County Registry of Deeds, Book 967, Page 380.

Article 28. To see whether or not the town will vote to raise and appropriate the sum of \$50.00 for advertising our natural resources, advantages and attractions, under the provision of Chapter 5, Section 82, Public Laws of Maine. Said money to be expended through the State of Maine Publicity Bureau.

Article 29. To act on any further business that may come before this meeting.

The selectmen hereby give notice that they will be in session at the Town Hall at nine o'clock in the forenoon on the day of said meeting, for the purpose of revising and correcting the list of voters.
