North Kennebunkport has been fortunate in retaining the services of a number of experienced teachers, and where inexperienced teachers have been employed, because of teacher shortage, such teachers have carried on the work of their schools in a satisfactory manner.

ENTRANCE AGE

The State Law provides that children may enter the sub-primary grade (when such a grade is provided) if they have attained age 5 on or before October 15, following the opening of school in September. Children may enter grade one provided they have attained the age of 6 on or before December 31, following the opening of school in September.

SUB — PRIMARY GRAD

In a rural school, where teachers must teach many grades, more satisfactory results would be obtained if the sub-primary grade were eliminated and all children were entered into grade one. A sub-primary grade requires a major part of the teacher's time, at the expense of the upper grades. If the children enter grade one, omitting the sub-primary grade, their progress in school will not be retarded, in fact, because they are older at the time of entering, and because the teachers have more time to devote to the children's needs, their progress will be even more rapid.

GRADE SEVEN AND EIGHT

All pupils in grades seven and eight should be transported to the nearest town, in order to provide a better foundation for high school work.

IRVING SCHOOL

If transportation can be arranged, the Irving School should be closed, because of the small number of pupils.

TRANSPORTATION

The employment of a bus contractor to furnish all necessary transportation, as suggested above, would facilitate this program. A bus with a capacity of 35 would be adequate and a schedule could be worked out.

HEATING

Oil burning heaters should be installed in all buildings. The present stoves are unsatisfactory and require janitorial attention which is difficult to get. Oil burners would provide better heating with less attention.

CONCLUSION

I have found all teachers working hard to serve the children and the community. Supplies, particularly books, have been plentiful. The three R's are still the most important part of the elementary program. Reading has received particular attention. Results have been as good as can be expected from mixed grades, and in some cases, large registrations.

I wish to extend to the School Board, teachers, parents and pupils my appreciation for their friendly cooperation.

AUDITOR'S REPORT

STATE DEPARTMENT OF AUDIT

Gentlemen:

In accordance with Chapter 16, Section 3, Revised Statutes of 1944 and at your request, the records of the Town of North Kennebunkport have been audited by Auditor M. W. Bragdon for the period February 7, 1945 to February 11, 1946 inclusive.

The examination was made in accordance with generally accepted auditing standards applicable in the circumstances and included all procedures which were considered necessary. Insofar as could be ascertained within the scope of the examination, the financial transactions of the town appear to have been appropriately handled.

Exhibits and schedules incorporated in this report impartially present the financial position of the town and the result of its operation for the period designated. A recommendation has been made which, we believe, is worthy of your consideration.

Comments and other data incorporated in this report may prove of interest to you. All of which is respectfully submitted.

COMMENTS

Re: Audit of Accounts— Town of North Kennebunkport, February 7, 1945 to February 11, 1946.

An examination has been made of the financial transactions of the Town of North Kennebunkport for the municipal year ended February 11, 1946.

This examination consisted of a thorough check of all cash received and disbursed and such test checks of other operations as seemed advisable. All asset and liability accounts were reviewed and verifications made to the extent deemed necessary.

CASH

In auditing the Treasurer's account it was found that a warrant had been issued to cover a duplicate check. Attention is called to Check No. 2608, and Check No. 3042, both, for \$58.03 and payable to the State of Maine. Only one payment was actually made to the State, Check No. 2608 being returned to the Treasurer uncashed. As warrants were issued for each check and so considered by the Treasurer in her disbursements, the actual cash balance at the close of the municipal year should have been \$58.03 more than shown. This amount has been set up as an account receivable due from the Treasurer.

ACCOUNTS RECEIVABLE

This account is made up of the amount due from the Treasurer as stated under Cash, and also expenditures made for state paupers in 1944 and 1945. It is believed all accounts are collectible in full.

TAXES RECEIVABLE

The 1945 tax commitment was found in agreement with the records of the Assessors as to total amount. The taxes committed, however, are not an exact copy of, the valuation records as to names and amounts as they should be.

Some prior years' taxes were collected during the year, but others that should be collectible still remained outstanding. Special attention should be given to these old tax accounts during the coming year.

TAX LIENS AND DEEDS

Payments received and adjustments allowed on tax liens and tax deeds were examined and verified with the records. The tax liens and deeds remaining unpaid were on file with the Treasurer and were checked in detail.

TAX ACQUIRED PROPERTY

Two properties were sold during the year, one at considerable profit to the town. Remaining properties should be liquidated at amounts equal to those carried on the balance sheet.

INVESTMENTS — BRIDGE ACCOUNT

This account represents money received from the Boston & Maine Railroad Co., plus accrued interest, for bridge repairs. The fund is on deposit with the Biddeford Savings Bank.

DEFERRED APPROPRIATION

At a special town meeting the Selectmen were given authority to repair the tractor, and appropriated \$2,500 for that purpose. It was further stipulated that this appropriation be raised by taxation in 1946.

SMITH PROPERTY INCOME

For some years the net income from sand and gravel sold off the Smith property owned by the town has been allowed to accumulate. This net income amounted to \$1,163.33 at the close of the year. It is understood this account is to accumulate until such time the voters at their annual town meeting decide on its disposition.

TRUST FUNDS

The trust fund held by the town was examined as to investment, and income received and paid out.

GENERAL

Corporate surety bonds covering the Tax Collector and Treasurer were found on file and appeared to be proper.

It is recommended that a check be drawn for Withholding Tax and Teachers' Retirement Fund deductions, then a receipt issued for their return and deposit into the General Fund until time for payment to the proper agency. The payments when made would be on properly authorized warrants. Thus the correct liability will be reflected on the town books at all times.

The records of the Town Clerk for the annual town meeting were not found in proper form at the time of the audit.

The complete report of the audit, as required by Chapter 80, Section 119, Revised Statutes of 1944, and amended by Chapter 84, Public Laws of 1945, is on file in the office of the Selectmen.

WARRANT

FOR ANNUAL MEETING MARCH 3, 1947

To Ethel E. Thompson, Constable of the Town of North
Kennebunkport, in said County:

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of North Kennebunkport, qualified by law to vote in town affairs, to assemble at the Town Hall, in said Town, on the third day of March, 1947, at ten o'clock in the forenoon, to act on the following articles, to wit:

Article 1—To choose a moderator to preside at said meeting.

Article 1A—To see whether the Town will vote that for the choice of the office of Selectman, Assessor and Overseer of Poor, the candidate receiving the largest majority shall be deemed to have been elected to fill the unexpired term of Kenneth H. Taylor; that the candidate receiving the second highest majority be deemed to be elected to fill the unexpired term of J. Eugene Gaudette; and the candidate receiving the third highest majority be elected for the term of one year; and that hereafter as terms expire, Selectmen, Assessors and Overseers of the Poor in said Town shall be elected to hold office for the term of one year, and the vote of said Town taken at the special Town Meeting held on the 8th day of November A. D. 1946 be and hereby is rescinded.

Article 2—To see if the Town will vote to dispense with the check list at this meeting.

Article 3—To choose all necessary Town officers for the ensuing year.

Article 4—To see what sum of money the Town will vote to raise for the support of the common schools.

Article 5—To see what sum of money the Town will vote to raise for High School tuition.

Article 6—To see what sum of money the Town will vote to raise for repairs and insurance on school buildings.

Article 7—To see what sum of money the Town will vote to raise for free text books.

Article 8—To see what sum of money the Town will vote to raise for school supplies.

Article 9. To see what sum of money the Town will vote to raise for salary of Superintendent of Schools.

Article 10—To see what sum of money the Town will vote to raise for the repair of roads and bridges.

Article 11—To see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour to be paid for labor on the highways.

Article 12—To see if the Town will vote to raise a-sum of four hundred and seven dollars to repair and maintain the Third Class Roads, to comply with Sections 43 to 47, Chapter 28, Revised Statutes of 1930, as amended by Chapter 175, Public Laws of 1933.

Article 13—To see what sum of money the Town will vote to raise for removal of snow.

Article 14—To see what sum of money the Town will vote to raise for the support of the poor.

Article 15—To see what sum of money the Town will vote to raise for the Contingent Fund.

Article 16—To see if the Town will vote the sum of \$75.00 for the services of a public school nurse as recommended by public health. This section made legal by the Maine Legislature of 1925, Section 58, Chapter 140, Public Laws of 1925.

Article 17—To see what sum of money the Town will vote to raise for the collection of Excise Taxes.

Article 18—To see if the Town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said town, due or to become due during the present municipal year, to be paid out of the money raised by taxation during the present, municipal year, the town treasurer be and hereby is authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate ten thousand dollars, and to execute and deliver the note or notes of the town, thereof, signed by the Town Treasurer and countersigned by the municipal officers of the Town.

Article 19—To see if the Town will authorize the treasurer of the Town (with the approval of the Board of Selectmen) to sell and dispose of all tax titles held by the Town on such terms as they deem advisable, and to execute quit claim deeds for such property.

Article 20—To see what sum of money the Town will vote to pay for the collection of taxes.

Article 21—To see what sum of money the Town will vote to raise for the services of out-of-town fire companies.

Article 22—To see if the Town will vote to have a Budget Committee consisting of six members to serve for one year, and to be appointed by the chair at each annual town meeting, as voted at special town meeting of November 8, 1946.

Article 23—To see how much money this Town will vote to raise by taxation to provide transportation for said children of this district as well as the other district of said Town, at the next regular town meeting, March 3rd, 1947. Charlotte Wilson, Henry D. Wilson, Harold Kimball, Charlotte dark, Mary Schiaffino, Miriam Coutant, Elsie Wilson, Elsie Fountain, Helen Whitten, Eunice Miller, Emily Andrews, Mary Hansen, Victor Bryant, Maud Holland, Mr. and Mrs. Chester M. Rogers, Mr. and Mrs. Frank Jordan, James Descoteaux.

Article 24—To see that the Selectmen are ordered to take such action as may be necessary to compel the Boston and Maine Railroad to install automatic signals, flagmen or other adequate safety devices to eliminate the extremely hazardous condition, at present threatening users of the two roads.

Article 25—To see if the Town will appropriate the sum of \$500.00 or such amount of money as may be necessary, to repair the bridges and culverts and open roadside ditches and make such other necessary repairs as are urgently needed on the road known as the Camp Ground Road and leading from U. S. Route 1 to the so called Limerick Road.

Article 26—To see if the Town will appropriate a sum of money sufficient to pay for the weekly clean-up and removal of all broken and un-broken beer and other bottles from the roads and road sides throughout the town as such broken glass is a menace to automobile traffic, the feet of children and domestic animals.

Article 27—To see if the Town will vote to raise the sum of \$200.00 to be spent under State Forestry supervision for the control of Pine Blister Rust.

The Selectmen hereby give notice that they will be in session at the Town Hall at nine o'clock in the forenoon on the day of said meeting, for the purpose of revising and correcting the list of voters.
