Dear Mr. Talbot:

I am pleased to report to you the accomplishments made on white pine blister rust control in North Kennebunkport. During 1953 we covered 2238 acres to protect 1055 acres of pine, most of which was young growing stock. We found and destroyed 15,673 wild currant and gooseberry bushes.

This amount of bushes is unusually high and as might be expected, we found a considerable amount of infection in the pine. We worked two areas, one a band areas, the town just west of Route No. 1 and the other in the southern part of the town. It was, in this southern part that conditions were the worst. I do earnestly recommend that your town continue this work until the towm is cleaned up. You have a large acreage of young pine in the unburned areas and it will in a few years provide a considerable tax base to the town.

The costs of this work were divided as follows: Town of North Kennebunkport \$3.83.40, State of Maine \$137.04, and the Federal Government \$252.00.

We appreciate the cooperation given up by the officials and citizens of North Kennebunkport in this work.

Report of the Public Health Nurse

Just as prevention and cure are two sides of the same problem, so are individual and community health. By guiding the family toward better health, by helping the family to prevent disease before it strikes, the Public Health Nurse safe-guards and improves the general health of the community as a whole.

The Public Health Nurse's activities take in many aspects of community health not commonly associated with nursing. For example, while visiting a family on an accident case, she may draw attention to the screenless windows and the danger of flies. When she assists in getting a birth registered, she is dealing with Vital Statistics. When she visits an infant and checks on formula she may point out the dangers of drinking unpasteurized milk.

During the past year, 23 visits were made to expectant mothers. The aim of these visits is to encourage mothers to get medical supervision as early as possible during pregnancy. Instruction is given about diet and hygiene during this period. The physician is notified of any abnormal symptoms discovered and the patient is advised to get medical attention.

Seventeen visits were made to mothers after delivery; 112 visits were made to infants. On these visits, instructions on daily care of the infant is given and the mother is encouraged to discuss any problems with the nurse.

Child Health Conferences are held to provide health supervision for infants and pre-school children who are not under private medical supervision. There was a total attendance of 55 at these conferences. Physical examinations were given to eight infants and to 20 pre-school children. Because of the difficulty in heating the Town Hall, these conferences are held only from April through October. A definite program of immunization against preventable diseases is offered as Child Health Conferences. The following immunications were completed:

Physical examinations were given to 16 fourth grade pupils. The main need is for better dental care. Poor teeth can seriously affect the general health. Hearing tests were given to 105 pupils from the third to the eighth grades. Six were found to have some hearing difficulty. The parents were notified and advised to check with their physician.

Where bedside nursing care is necessary, the nurse gives the care and teaches nursing care to someone in the home who is able to care for the patient. It is necessary to limit the number of visits to the chronically ill. Forty-eight visits were made to these patients during the past year, Cancer and heart disease are still the most frequent types of chronic illness that the nurse encounters.

In many homes the nurse finds that mental, emotional, or social problems are a handicap to the family's well-being and an obstacle to the recovery of the sick. She helps the family to a better understanding of the problems and explains how other community agencies can assist them.

I want to take this opportunity to thank all those who have helped to make the program a success. I am especially grateful to the Health Council for providing volunteer assistance when needed. With your continued support, I hope to develop further programs during 1954.

It appeared as arrangements progressed, that the money appropriated might not be adequate to complete the project. I am still hopeful that ways and means may be found to carry out this program of improvement. Reconsideration of plans might lead to new suggestions as to additional financing such as (1) use of local labor (2) donation of lumber and other materials (3) financial gifts (4) further simplifying of the proposed plans.

In case nothing can be done on the current, project, I would recommend the following as the best remaining solution:—

1. close the Irving and Iron Bridge Schools.
2. operate North Chapel, Durell and Burnham.
3. place the above mentioned three buildings in good physical condition.
4. transport grades 7-8 (37 pupils next year) to surrounding Towns (provided arrangements can be made).

This plan would, save salaries of two teachers and reduce the number of grades for each remaining teacher. It would also provide better educational facilities for the upper two grades just previous to their entrance into High School. There would be additional costs in transportation and tuition.

The plans for establishing a School District and for making use of the State Building Authority have already been refused by the Town. It appears that some plan related to the renovation of the present buildings or that transportation of some grades out of Town, are the only remaining possibilities by which the situation can be improved.

I wish to call attention to the service of the present Building Committee who have given much time and thought in an endeavor to solve this problem of school housing in North Kennebunkport.

I wish to thank the School Committee and all others who have taken interest in the welfare of the schools.

Local Health Officer

The State law requires the Local Health Officer to provide annually free smallpox vaccinations to all citizens or The Town and inoculate against diphtheria and whooping cough to all children under 12 years of age – All charges to be paid by the town.

In accordance with this law we vaccinated 21, diphtheria and tetanus 15. Diphtheria, whooping cough and tetanus 5.

Communicable diseases reported this year to me were measles, 14; chickenpox, 13; streptococcal nasopharyngitis, 5; mumps, 3; whooping cough, 3. Many other cases not reported.

All cases of communicable diseases should be reported to the Health Officer whether you have a doctor or not.

The Town Treasures be and hereby is authorized and directed to borrow from time to time a sum or sums not to exceed in the aggregate; Ten Thousand Dollars, and to execute and deliver the note or notes of the Town therefore signed by the Town Treasurer and countersigned by the Municipal Officers of the Town.

Art. 22. To see if the Town will authorize the Treasurer of the Town (with the approval of the Selectmen) and the Town's interest in tax liens whether completely foreclosed or not, on such terms as the selectmen deem advisable and to execute quit claim deeds for such property.
