## VOLUNTEER SOLDIERS,

RESIDENTS OF KENNEBUNK, WHO ENLISTED IN 1861.



AMOS C. EMERSON, son of Washington Emerson ; 1st Regt., Co. I, United States Artillery. He enlisted in April, 1861, and was discharged at the expiration of his term of service, in April, 1864.

JOSEPH C. HILL, Sergeant, a law-student, formerly of York ; 2d Regt., Co. B, Mass. Infantry. He enlisted May 11, 1861 ; by an unexplained cause was discharged in July, 1861. He was mustered in Second Lieutenant of Co. A, First Regt. Maine Cavalry, Oct. 31, 1861, which position he resigned, Oct. 24, 1862. He was in Kennebunk but a few months before the war commenced, and did not return after the war was over.

ROBERT HATCH, Sergeant, son of Robert P. Hatch ; 2d Regt., Co. B, Mass. Infantry. He enlisted May 11, 1861, was promoted sergeant Aug. 1, 1861, in place of J. C. Hill. At the battle of Cedar Mountain, Va., Aug. 9, 1862, he was wounded by a shot in his shoulder ; will probably lose the use of his arm during life, as it was paralyzed when he was discharged by a certificate of disability at Fort McHenry, Baltimore, Md., Oct. 30, 1862.

HARRISON SARGENT, adopted son of N. K. Sargent ; 2d Regt., Co. B, Mass. Infantry. He enlisted May 11, 1861, was discharged by a certificate of disability, May 17, 1862. He was mustered into the 5th Regt., Co. C, Maine Infantry, as a recruit, Sept. 19, 1862, and died of consumption, at Point Lookout Hospital, Md., Feb. 15, 1865, aged 34 years.

JOHN L. TAYLOR, Corporal, son of James Taylor ; 2d Regt. Co. B, Mass. Infantry. He was enrolled May 17, 1861, and discharged, Dec. 9, 1863, at Estell Springs, Tennessee, by reason of second enlistment in the same Regt. and Co. His second discharge was at Washington, D. C., July 14, 1865.

THATCHER J. HUFF, son of Seth Huff, of Kennebunkport ; 2d Regt., Co. B, Mass. Infantry. He enlisted in May, 1861, was wounded in his right side and arm, at the battle of Cedar Mountain, Va., Aug. 9, 1862, was a prisoner in Richmond one month. Discharged by a certificate of disability, at Alexandria, Va., Feb. 5, 1863.

EDWARD B. BUTLAND, son of Isaac Butland ; 2d Regt., Co. B, Mass. Infantry. He enlisted in May, 1861, was wounded in his side, at the battle of Chancellorsville, Va., May 3, 1863. Discharged at Chattanooga, Tenn., May 23, 1864, his term of service having expired.

JESSE M. STEVENS, son of Frederick Stevens, 2d Regt., Co. B, Mass. Infantry. He enlisted in May, 1861, was killed at the battle of Chancellorsville, Va., May 3, 1863, aged 23 years.

JAMES PORTER HILL, son of Alvah Hill ; 2d Regt., Co. B, Mass. Infantry. He enlisted in May, 1861. Near the close of the year 1862, by the consent of the officers of the 2d Regt., he enlisted in the 4th Regt., Co. F, U. S. Regular Artillery. He was discharged from the U. S. service in March, 1867.

JOHN G. KNIGHTS, son of Abel Knights ; 2d Regt., Co. K, Mass. Infantry. He enlisted in May 1861, and died of fever, Feb. 10, 1862, in Frederick city, Md., aged 20 years. His remains were brought home.

JOSHUA HATCH, JR., son of Joshua Hatch ; 5th Regt., Co. D, Mass. Infantry, a three months regiment. He enlisted in May, 1861, and received his first discharge in August, 1861. He afterwards re-enlisted as Sergeant, for nine months' service in the 50th Regt., Co. G, Mass. Infantry.

EDWARD W. KIMBALL, Wagoner, son of Joseph Kimball, farmer, 11th Regt., Co. F, Mass. Infantry. He was enrolled April 30, 1861, and discharged from U. S. service, June 24, 1864, at Boston, Mass., by reason of three years' service. Copy of a note on his discharge ; "Participated in McDowell's, McClellan's, Pope's, Burnside's, Hooker's, Meade's, and Grant's campaigns,—a brave and true soldier."

MICAJAH POPE, known in the army as William Ross ; 42d Regt., Co. C, New York Infantry. He enlisted, Aug. 16, 1861 ; was detached from this Regt., August, 28, 1861, to the "Signal



Corps" of the Army of the Potomac. Was discharged at the headquarters of that army, August 16, 1864, in consequence of expiration of his term of service. Note on his discharge: "A good and faithful soldier."

GEORGE G. DOWNING, son of John Downing; 2d Regt., of Maine Infantry. He was mustered in as a musician, August 30, 1861, and discharged in the summer of 1862, by Act of Congress discharging regimental bands of music.

ALBERT WEBBER, son of Johnson Webber; 5th Regt., Co. B, Maine Infantry. Mustered in, June 24, 1861. While retreating with the army of the Potomac, June 27, 1862, from near Richmond, Va., to James river, he was shot and taken prisoner. He died of his wound, the next day, aged 21.

SETH PRENTISS WHITTEN, son of Seth Whitten; 5th Regt., Co. B, Maine Infantry. He was mustered in, June 24, 1861, and deserted July 25, 1861; afterwards re-enlisted by the name of JOHN P. HILL, (as is reported,) in the 8th Regt., Co. I, New Hampshire Infantry. He died of fever in a New Orleans hospital, August 16, 1862, aged 19.

LORENZO S. EMERY, son of Joshua Emery, Jr.; 5th Regt., Co. C, Maine Infantry. He was mustered in, June 24, 1861, and deserted Sept. 7, 1861, according to published report of the Adjutant General.

BENJAMIN E. BURGESS, son of Richard Burgess; 7th Regt., Co. D, Maine Infantry. Mustered in, August 21, 1861. While assisting to convey a stick of timber in the trenches at Yorktown, his back was badly hurt. He was discharged in Oct., 1862, at Centre street hospital, at Newark, N. J., in consequence of injuries received in the service. Died at home, December 18, 1862, aged 20.

GEORGE W. EMERSON, son of Washington Emerson; 7th Regt., Co. G., Maine Infantry. Mustered in August 21, 1861. He was discharged, by a certificate of disability, March 8, 1862, at Camp Griffin, Fairfax County, Va. [See 27th Regt.]

WASHINGTON EMERSON, Corporal, formerly of Portland; 8th Regt., Co. F, Maine Infantry. Mustered in, Sept. 7, 1861. He died of consumption, at Port Royal, South Carolina, Dec. 27, 1863, aged 42.

SAMUEL COLE, Sergeant, son of John Cole ; 8th Regt., Co. F, Maine Infantry. Mustered in, Sept. 7, 1861. He was discharged from U. S. service, Sept. 15, 1864, at Augusta, Maine, by reason of three years' service.

PLUMMER A. ADJUTANT, son of George W. Adjutant ; 8th Regt., Co. F, Maine Infantry. Mustered in, Sept. 7, 1861. In March, 1864, he re-enlisted in the same regiment and company. Was discharged at Fortress Monroe, Jan. 19, 1866.

WILLIAM H. CLARK, son of Abiathar Clark ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Sept. 7, 1861 ; died of chronic diarrhœa, at U. S. Hospital in Philadelphia, Oct. 20, 1864, aged 20 years. His remains were brought home.

GEORGE STORER DUTCH, formerly of Brownfield ; 8th Regt., Co. F., Maine Infantry. He was mustered in, Sept. 7, 1861 ; was wounded in his left leg, at the battle of Cole Harbor, June 3, 1864, and discharged by a certificate of disability, June 1, 1865, at the hospital in Augusta, Maine.

DAVID H. KNIGHTS, son of Abel Knights ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Sept. 7, 1861, and died at Hampton, Va., Hospital, April 18, 1865, aged 21 years.

OLIVER M. COUSENS, son of Jeremiah Cousens ; 8th Regt. Co. F, Maine Infantry. He was mustered in, Sept. 7, 1861, and discharged by a certificate of disability, June 24, 1862.

HORACE JUNKINS, Corporal, son of James Junkins ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Sept. 7, 1861 ; was reported "Missing," May 16, 1864, and not heard from since. He was 30 years of age.

EMERSON SMITH, son of Jeremiah Smith ; 10th Regt., Co. A, Maine Infantry. He was mustered in, Oct. 4, 1861, and discharged by a certificate of disability, at Stafford Court House, Va., April 24, 1863.

JOHN MOODY, son of James Moody ; 10th Regt., Co. A, Maine Infantry. He was mustered in, Oct. 4, 1861, and died of fever, at the Relay House, near Baltimore, Md., Jan. 3, 1862, aged 21 years. His remains were brought home.

FREDERICK STEVENS, JR., son of Frederick Stevens ; 10th Regt., Co. A, Maine Infantry. He was mustered in, Oct. 4,

1861, and deserted May 13, 1863, according to published report of the Adjutant General.

NAHUM LITTLEFIELD, son of Abram Littlefield; 10th Regt., Co. A, Maine Infantry. He was mustered in, Oct. 4, 1861, and discharged by certificate of disability, at Stafford Court House, Va., April 24, 1863.

GEORGE W. HATCH, son of Joseph Hatch; 10th Regt., Co. A, Maine Infantry. He was mustered in, Oct. 16, 1861, and discharged at Augusta, Me., Oct. 18, 1864, by reason of expiration of term of service. He was transferred to the 29th Regt., a few months before his discharge.

BENJAMIN F. OAKES, Sergeant, son of Benjamin Oakes; 1st Regt., Co. E, Maine Infantry. He was mustered in at Portland, May 3, 1861, for three months' service, and mustered out at the same place, Aug. 5, 1861. He then re-enlisted in the 10th Regt., Co. E, Maine Infantry. Mustered in, Oct. 4, 1861; was wounded at the battle of Antietam, Sept. 17, 1862, and discharged by a certificate of disability, at Buttonwood street hospital, Philadelphia, Dec. 23, 1862.

JOSEPH LITTLEFIELD, Corporal, son of John Littlefield; 10th Regt., Co. A, Maine Infantry. He was mustered in, Oct. 16, 1861. While in Tennessee, Feb. 22, 1864, he re-enlisted in the 29th Regt., Co. F; was discharged by a certificate of disability at Hilton Head, S. C., May 21, 1866.

ROBERT P. JUNKINS, son of Paul Junkins; a musician in the 1st Regt. of Maine Cavalry. He was mustered in, Oct. 31, 1861, and discharged at Warrington, Va., Aug. 26, 1862, by order discharging regimental bands of music.

TRISTRAM GOODWIN, son of Ivory Goodwin; a musician in the 1st Regt. of Maine Cavalry. He was mustered in, Oct. 31, 1861, and discharged at Warrington, Va., Aug. 26, 1862, by order discharging regimental bands of music.

ORVILLE D. BRYANT, son of William M. Bryant; a musician in the 28th Regt. of Mass. Infantry. He was mustered into the army in the fall of 1861, and discharged in the summer of 1862, by order discharging regimental bands of music.

LEWIS W. BUTTERFIELD, formerly of Chesterville; 12th Regt., Co. H, Maine Infantry. He was mustered in, Nov. 15,

1861, and died of yellow fever in St. James hospital, New Orleans, June 9, 1862, aged 34.

ISRAEL KIMBALL, son of Israel Kimball; 6th Regt., Co. H, New Hampshire Infantry. He was enrolled, Nov. 16, 1861, and discharged by a certificate of disability at Island Hall general hospital in Washington, D. C., Dec. 16, 1862.

JOHN W. HANSCOM, formerly of Portsmouth, N. H.; 14th Regt., Co. K, Maine Infantry. He was mustered in, Dec. 17, 1861, and discharged by a certificate of disability from the St. James hospital, New Orleans, June 25, 1862. (See 2d Cavalry Regt.)



#### WHO ENLISTED IN 1862.

JOHN BUNKER, a barber, former residence unknown; in Jan. or Feb., 1862, he enlisted as a musician in the 1st Regt., of Maine Cavalry, was taken sick before he was mustered into U. S. Service and died of congestion of the lungs, in the hospital at Augusta, March 2d, 1862, aged 24 years,

X JOSEPH G. KNIGHTS, son of Abel Knights; 31st Regt., Co. B, Mass. Infantry. He enlisted in the spring of 1862, was discharged by a certificate of disability from St. James' hospital, New Orleans, June 20th, 1862.

BENJAMIN REMICH, formerly of Strong; 8th Regt., Co. H, Maine Infantry. He was mustered in, Feb. 11, 1862; re-enlisted in the same regiment and company, Feb. 29, 1864; was discharged at Fortress Monroe, Jan. 19, 1866.

F. AUGUSTUS BUTLAND, Sergeant, son of Isaac Butland; 17th Regt., Co. K, Maine Infantry. He was mustered in, Aug. 18, 1862; wounded in both legs at the battle of Gettysburg, Penn., July 3, 1863, and died in a hospital in that place, Sept. 5, 1863, aged 32 years. His remains were brought home.

ALVAH JELLESON, son of Ivory Jelleeson; 19th Regt., Co. K, Maine Infantry. He was mustered in, August 25, 1862; wounded in his left thigh, at the battle of Gettysburg, Penn., July 3, 1863; discharged by a certificate of disability, at Christian Street hospital, Philadelphia, March 1, 1864.

CHARLES M. KIMBALL, son of Simon Kimball ; 5th Regt., Co. G, Mass. Infantry. He was mustered into U. S. service, Oct., 1862, to serve nine months, and mustered out, at Wenham, Mass., July 2, 1863.

SAMUEL C. THOMPSON, son of Benjamin F. Thompson; 36th Regt., Co. I, Mass. Infantry. He was mustered in, Sept., 1862, and died of chronic diarrhœa, at Portsmouth Grove, Rhode Island hospital, Jan. 25, 1864, aged 22 years. His remains were brought home.

GEORGE H. OAKES, son of Bradford Oakes; 43d (Tiger) Regt., Co. K, Mass. Infantry. He was mustered into U. S. service, Oct. 30, 1862, to serve nine months, and mustered out, July 30, 1863.

ENOCH F. MITCHELL, son of James Mitchell; 44th Regt., Co. B, Mass. Infantry. He was enrolled August 29, 1862, to serve nine months, and was discharged June 18, 1863, at Readville, Mass.

He was employed also in the Construction Corps of the U. S. Military Railroad Division of Mississippi, from August 29, 1864 to April 8, 1865, when he was honorably discharged at Newbern, N. C. When he enlisted in the army he was, for a short time only, a resident of Newton, Mass. Soon after that time, his wife and family returned to Kennebunk.

Twenty-nine soldiers, from Kennebunk in August, 1862, received from the town a bounty of \$4325, that is, 28 recruits for old regiments received \$150 each, and one soldier, who joined a new regiment, received \$125.

ALVAH J. RIDEOUT, son of John H. Rideout ; 8th Regt., Co. B, Maine Infantry. He was mustered in, August 15, 1862. In a skirmish near Petersburg, Va., July 30, 1864, he was reported "Missing." It was afterwards ascertained that he died in prison at Florence, S. C., Nov. 15, 1864, aged 36.

ORRIN R. LITTLEFIELD, son of Leonard Littlefield; Regt., Co. B, Maine Infantry. Mustered in, Aug. 16, 1862, and discharged at Richmond Va., June 11, 1865.

GEORGE A. WENTWORTH, formerly of Ossipee, N. H. ; 8th Regt., Co. B, Maine Infantry. Mustered in, Aug. 15, 1862, and discharged at Richmond, Va., June 11, 1865.

JOHN W. TREADWELL, son of Joshua E. Treadwell ; 8th Regt., Co. C, Maine Infantry. Mustered in, Aug. 15, 1862, and discharged at Richmond, Va., June 11, 1865.

ELEAZER CLARK, Jr., son of Eleazer Clark, of Wells ; 8th Regt., Co. C, Maine Infantry. Mustered in, Aug. 15, 1862. He was promoted to the quarter-master's department, as commissary Sergeant of non-commissioned staff, Jan. 16, 1865. Was discharged at Richmond, Va., June 11, 1865.

JESSE H. WEBSTER, son of Charles Webster ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Aug. 11, 1862, and discharged by certificate of disability at Portsmouth Grove, R. I., hospital, April 5, 1864.

CHARLES J. WEBSTER, son of Charles Webster ; 8th Regt., Co. F Maine Infantry. He was mustered in, Aug. 11, 1862, and died of typhoid fever at Hilton Head, South Carolina, June 10, 1863, aged 19.

ALBERT JUNKINS, son of James Junkins ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Aug. 15, 1862, and discharged at Richmond, Va., June 11, 1865.

WILLIAM JUNKINS, son of James Junkins ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Aug. 15, 1862, and died suddenly of heart disease, at Richmond, Va., March 29, 1865, aged 32.

CYRUS B. GOFF, son-in-law of James Junkins ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Aug. 15, 1862 ; taken prisoner at the battle of Fair Oakes, Va., Oct. 27, 1864, was in Libby prison at Richmond until paroled Feb. 28, 1865. Mustered out of service, July 16, 1865.

EDMUND D. VAUGHAN, grandson of Benjamin Brown ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Aug. 15, 1862 ; taken prisoner at the battle of Fair Oakes, Va., Oct. 27, 1864, died in prison at Andersonville, Ga., in the winter of 1864-5, aged 21.

JOHN P. DUTCH, son of Jeremiah Dutch ; 8th Regt., Co. F, Maine Infantry. Mustered in, Aug. 15, 1862 ; died of typhoid fever at Hilton Head, S. C., July 8, 1863, aged 19.

CHARLES F. GRANT, son of Samuel Grant, of Alfred ; 8th Regt., Co. F, Maine Infantry. Mustered in, Aug. 15, 1862. Discharged at Richmond, Va., June 11, 1865.



WILLIAM H. COLLINS, formerly of Prince Edward's Island ; 8th Regt., Co. F, Maine Infantry. Mustered in, Aug. 15, 1862. Discharged at Richmond, Va., June 11, 1865.

LYMAN MAXWELL, formerly of Belgrade ; 8th Regt., Co. E, Maine Infantry. Mustered in, Aug. 15, 1862. While going from White House Landing to Coal Harbor, Va., June 3, 1863, he was taken prisoner by guerillas. He died in prison at Andersonville, Ga., Nov. 14, 1864, aged 28.

HENRY D. SIMPSON, son of Merrill Simpson ; 8th Regt., Co. E, Maine Infantry. Mustered in, Aug. 18, 1862, discharged at Galloup's Island, Boston harbor, May 15, 1865.

BENJAMIN HUBBARD, son of Charles Hubbard ; 8th Regt. Co. C, Maine Infantry. Mustered in Aug. 15, 1862, discharged at Richmond, Va., June 11, 1865. By his discharge, he was in seventeen engagements while in the army ; yet he says he was not wounded in battle, or otherwise hurt, while in the U. S. Service.

CHARLES NASON, son of Moses Nason of Kennebunkport : 8th Regt., Co. F, Maine Infantry. Mustered in, Aug. 15, 1862. He was appointed Chaplain to the Regiment, Aug. 20, 1862, and discharged from U. S. service, by resignation, July 1, 1863. (See 2d Cavalry Regt.)

CHARLES H. NASON, son of Charles Nason ; 8th Regt., Co. F, Maine Infantry. Mustered in, Aug. 15, 1862. He was transferred from volunteer service to the 12th Regt. U. S. Regular Infantry, Nov. 13, 1862 ; was taken prisoner near Culpepper, Va., in Nov., 1863, and died in prison at Andersonville, Ga., March 31, 1864, aged 20.

ALVIN E. GRIFFIN, son of Charles Griffin of Hollis ; 8th Regt., Co. F, Maine Infantry. Mustered in, Aug. 15, 1862. He was transferred from the volunteer service to the 12th Regt., Co. F, U. S. Regular Infantry, Nov. 11, 1862, where he was Sergeant. Was discharged at Richmond, Va., Nov. 11, 1865, in consequence of expiration of term of service. The following list of battles in which he participated are named on his discharge—Bristow Station, Oct. 14, 1863 ; Rappahannock Station, Nov. 7, 1863 ; Mine Run, Nov. 27, 1863 ; Wilderness, May 5, 1864 ; Coal Harbor, June 2d and 3d, 1864 ; Petersburg, June 30, 1864 ; Weldon Railroad, Aug. 18, to 21, 1864 ; Preble Farm, Sept. 30, 1864 ; and Chapel House, Oct. 1, 1864 ;

MARSHALL LOWELL, son-in-law of Oliver Perkins ; 8th Regt., Co. F, Maine Infantry. Mustered in, Aug. 13, 1862. He died suddenly at Augusta, Me., Oct. 10, 1862, aged 42. His remains were brought home.

CHARLES BENNETT, formerly of Alfred ; 8th Regt., Co. K, Maine Infantry. Mustered in, Aug. 11, 1862, wounded May 20, 1863, at Gibbs' Farm, discharged at Richmond, Va., June 11, 1865.

CALVIN BOSTON, son of Nathan Boston, of Kennebunkport ; 8th Regt., Co. K, Maine Infantry. Mustered in, Aug. 15, 1862, wounded July 6, 1863, at Petersburg, discharged at Richmond, Va., June 11, 1865.

CHARLES BROWN, son of Samuel Brown ; 8th Regt., Co. K, Maine Infantry. Mustered in, Aug. 15, 1862, wounded Jan. 18, 1865, at Petersburg, discharged by certificate of disability at Camp Westwood, near Richmond, Va., April 27, 1865.

JOSEPH T. BROWN, son of John Brown ; 8th Regt., Co. K, Maine Infantry. Mustered in, Aug. 15, 1862, discharged by a certificate of disability at Hilton Head, S. C., May 9, 1863.

JAMES VEAZIE, formerly of East Madison, N. H. ; 8th Regt., Co. K, Maine Infantry. Mustered in, Aug. 15, 1862, died of typhoid fever, July 29, 1864, at Portsmouth, Va., aged 45.

BENJAMIN F. HAWKES, a resident of Buxton ; 8th Regt., Co. F, Maine Infantry. He was mustered in, Aug. 25, 1862, and died of fever at Port Royal, S. C., July 1, 1863, aged 24. B. F. Hawkes is here included, because his mother received his bounty here, and in the Adjutant General's report, his residence is said to be Kennebunk.

EDWIN B. VEAZIE, son of James Veazie ; 10th Regt., Co. F, Maine Infantry. He was mustered in, Aug. 18, 1862, and died in the general hospital, near Falmouth, Va., May 17, 1863, aged 19.

JACOB T. LOCKE, Corporal, son of James Locke, of Hollis ; 16th, Regt., Co. F, Maine Infantry. He was mustered in, Aug. 14, 1862, and discharged by a certificate of disability, July 15, 1863.



## NINE MONTHS MEN.

FORTY-SIX SOLDIERS WHO ENLISTED IN SEPT., 1862, FOR NINE MONTHS  
IN THE U. S. SERVICE.

They received from the town of Kennebunk, a bounty of \$200 each, amounting to \$9,200. They all enlisted in the 27th Regt., Co. I, Maine Infantry, except John Q. A. Ford, who was in the 25th Regt., Co. A, Maine Infantry.

When Company I was organized, Sept. 17, 1862, James M.  
 Stone was chosen Captain. When the 27th Regiment was organ-

ized, Sept. 19th, he was elected Major, and on the 11th of Feb. 1863, was commissioned Lieutenant Colonel.

This Regiment was mustered into U. S. Service Sept. 30, 1862. It was not in any engagement, being employed on picket duty in Virginia, part of the time at Arlington Heights, part of the time in the vicinity of Hunting Creek, and still another part at Chantilly, on the outermost line of Infantry in the defences of Washington. The Regiment was mustered out of service at "Camp Abraham Lincoln," near Portland, July 17, 1863. The forty-five men in this Regiment, from Kennebunk, returned to their respective homes in supposed good health.

Members of the Republican party subscribed \$1200, and members of the Democratic party subscribed \$1200, in order that each of the above drafted and accepted men might, if they wished, pay their commutation fee or hire a substitute ; and each of the above men did accept \$300 for that purpose.

WILLIAM A. PARSONS, was at sea when the above men were examined. When he returned he was examined, accepted, and paid a commutation fee of \$300. The town afterwards refunded to him \$275.



#### WHO ENLISTED IN 1863.

Thirty-four soldiers, being the quota of Kennebunk, under the President's proclamation of Oct. 17, 1863. Of these 34 men, 12 were obtained in this town, by a bounty of \$300 each, amounting to \$3,600 ; twenty-two strangers were obtained elsewhere at

\$275 each, amounting to \$6,050. Whole amount of bounty paid the 34 soldiers, \$9,650.

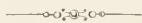

FRANK STEVENS, son of Ivory Stevens; 30th Regt., Co. C, Maine Infantry. He was mustered in, Dec. 19, 1863, and died of chronic diarrhœa, in Virginia, July 24, 1864, aged 21.

SETH E. BRYANT, son of William M. Bryant ; Captain of Co. A, 32d Regt., Maine Infantry. He was mustered in, March 3, 1864, and resigned his commission, while in front of Petersburg, Va., Nov. 25, 1864.

STEPHEN G. DORMAN, formerly of Sanford ; First Lieutenant of Co. K, 32d Regt., Maine Infantry. He was mustered in, May 6, 1864, and resigned his commission Aug. 24, 1864.

CHARLES S. HUBBARD, Sergeant, son of Charles Hubbard ; 32d Regt., Co. K. Maine Infantry. He was mustered in, May 6, 1864. While in "a charge" in front of Petersburg, Va., July 30, 1864, he was shot in his abdomen, and died of his wound the next day, aged 21 years.

HENRY P. SHOREY, a recruit, son of Wyman Shorey, of Waterville ; 1st Regt., Co. M., Maine Cavalry. He was mustered in, Jan. 26, 1864. In a skirmish at Ryansville Creek, Va., Oct. 27, 1864, he was wounded, taken prisoner, carried to Richmond, where he died in Libby prison, Dec. 7, 1864, aged 29 years.

CHARLES H. ROBINSON, a recruit, son of Andrew Robinson ; 1st Regt., Baker's District of Columbia Cavalry. He enlisted at Waterville, Jan. 20, 1864, was mustered in, Feb. 8, 1864, and soon after transferred to the First Maine Cavalry Regt., Co. C. He died of typhoid fever, at City Point, Va., hospital, Sept. 27, 1864, aged 20 years.

ALBERT F. PITTS, a recruit, son of Benjamin Pitts ; 29th Regt., Co. E, Maine Infantry. He enlisted in Portland, March 26, 1864, and was discharged at Galloup's Island, Boston harbor, June 10, 1865, without joining the Regt.

CHARLES F. HATCH, a recruit, son of George W. Hatch ; 9th Regt., Co. E, Maine Infantry. He was enrolled in Portland,

Oct. 5, 1864, for one year's service, and discharged at Raleigh, N. C., July 13, 1865.

WILLIAM C. GOODWIN, a recruit, son of Simeon Goodwin ; 11th Regt., Co. C, Maine Infantry. He was enrolled in Portland, Oct. 8, 1864, for one year's service, and discharged at Richmond, Va., Oct. 7, 1865.

CHARLES P. WHITTEN, a recruit, son of Seth Whitten ; 12th Regt., Co. F, Maine Infantry. He was mustered in, Feb. 23, 1865, and died of chronic diarrhœa, at David Island hospital, New York, Oct. 2, 1865, aged 17 years.

WILLIAM GILPATRICK, a recruit, son of James Gilpatrick ; 12th Regt., Co. H, Maine Infantry. He was mustered in, March 13, 1865, for one year's service, and discharged at Savannah, Ga., March 16, 1866.



#### IN NAVAL SERVICE.

WILLIAM SYMONDS, son of Col. Archelaus F. Symonds, of N. H. ; commissioned ensign in the Navy, Feb. 11, 1864. Was appointed Sailing Master, on board gunboat "Pinola." On account of ill health, he resigned his commission Jan. 17th, and received his discharge June 20, 1865.

HENRY F. CURTIS, son of Capt. Ralph Curtis ; commissioned Ensign in the Navy, May 23, 1864. Was appointed to command the torpedo boat "Gamma" on James river, nine miles below Richmond, Va., afterwards in the Sounds of North Carolina. He was discharged in New York, Nov. 15, 1865.

JOHN C. LORD, son of Capt. John Lord ; commissioned Ensign in the Navy, June 22, 1864. Was appointed Sailing Master on board steamer "Yantic," afterwards Navigator on board gunboat "Gettysburg." He was discharged Aug. 23, 1867.

EDWARD THOMPSON, son of Theodore Thompson ; was enrolled in the Navy, May, 1864 ; appointed Master's mate on board steamer "Niagara," afterwards on board steamer "Vanderbilt." He was discharged in New York, Feb. 28, 1865.

SAMUEL W. BROWN, son of Capt. Theodore Brown ; enlisted in Boston, Aug. 1, 1861, for two years' service. Was on



board gunboat "Louisville," until Aug. 8, 1863, when he was discharged.

FREDERICK H. LITTLEFIELD, son of Lance Littlefield ; enlisted April 16, 1861, was on board brig "Perry," then transferred to the steamer "Santiago De Cuba," where he remained until his time of service expired, when he was discharged June 3, 1864.

GUSTAVUS B. LITTLEFIELD, son of Lance Littlefield ; enlisted May 13, 1861, for one year's service ; was on board steamer "Niagara," until discharged, June 20, 1862.

JOSEPH S. BROWN, son of John Brown at the Port ; enlisted in New York, Sept. 30, 1861. Served on board steamer "Shawsheen," twenty-three months, then transferred to steamer "Miami." Was discharged at City Point, Va., Oct. 3, 1864.

CHARLES H. THOMPSON, son of Joseph Thompson ; enlisted in New Bedford, Mass. Oct. 1, 1861. Served on board ship "Shephard Knapp," of the West India Squadron, until Jan. 7, 1863, when he was discharged at the Navy Yard, in Charlestown, Mass.

JEREMIAH P. WORMWOOD, son of Ezekiel Wormwood ; enlisted in Portsmouth, N. H., April 17, 1862. Was on board gunboat "Mohaska" about twenty-nine months; then transferred to the gunboat "Nipsic." Discharged in Portsmouth, N. H., April 22, 1865.

FRANK KIMBALL, son of Samuel Kimball ; enlisted in the spring of 1862. Was on board bark "Midnight" fifteen months, when he was discharged in New York, Oct. 26, 1863.

JOHN PRING, formerly of Nova Scotia ; enlisted in Portsmouth, N. H., in Sept. 1864 ; was on board steamer "Colorado" until March, 1865, when he was discharged at Brooklyn, N. Y.

DANIEL M. CHAPMAN, son of Daniel Chapman of Ipswich, Mass ; enlisted in New York, July 20, 1864, was on board the transport "Queen." He was discharged in New York June 9, 1865.

GREENLEAF C. HUTCHINS, son of Oliver Hutchins ; enlisted in New York, July 20, 1864. Was on board the transport "Queen," then on the gunboat "Shawmut" from July, 1865, to Dec.



1866, then on board the gunboat "Peoria" until July, 1867, when he was discharged at Norfolk, Va.

ADAM McCULLOCH, JR., son of Adam McCulloch ; he was transferred from the 2d Cavalry Regt., June 30, 1864, to sloop of war "Lackawana," where he was rated quarter-master. He died of chronic diarrhoea at Barancas, Fla., Dec. 31, 1864, aged 34 years.

JOHN W. HANSCOM, formerly of Portsmouth, N. H ; he was transferred from the 2d Cavalry Regt., June 30, 1864, to gunboat "Metacomet." He was discharged, by a certificate of disability, in Philadelphia, Nov. 12, 1864.

PHILIP LYNCH, colored ; lived when young with Jos. Waterhouse. Enlisted in the spring of 1865, was on board Sloop of War "Vandalia." He remains in the Naval Service.

It will be remembered that the number of 168 does not represent actual men, but enlistments, of which 21 of our townsmen had their names twice enrolled.

Forty-two soldiers and six seamen enlisted previous to Aug. 1, 1862. They did not receive any bounty from the town. All who did enlist in the Army or Navy, after that date, received this additional inducement, excepting those who enlisted as commissioned officers,

including chaplains, who do not by law receive a bounty or count in a quota.

In addition to the 168 residents of this town, 78 substitutes were obtained out of town, to furnish the required quota, hence the whole number of enlistments for Kennebunk were 168 and 78, making a total of 246.

The amount of bounties paid by the town of Kennebunk, to residents and non-residents, was \$46,205 50

The exact expenses of the town, attending the enrollment and enlistment of the men, cannot now be ascertained, as the office of the Selectmen, with their books and papers, were burnt Nov. 25, 1866. The least estimated expense is
